## LISA UPDATE (SB):

- Coastal Season nearing completion
  - District Cup Finals this upcoming weekend at Starlight and Goudy
- Island Cup took place this past weekend
  - Mixed results for LISA teams
  - 2 games not played due to snow
    - Hope to make up in April
- U13 Festival to take place Aprli 6<sup>th</sup>/7<sup>th</sup> hosted by Lakehill
  - Just waiting on field permits from Saanich
- LISA Player Pathway meeting was held on February 18<sup>th</sup>
  - LISA has circulated the notes from the meeting
  - Looking to schedule the follow up TD meeting in April
  - Integra Solutions has provided a proposal for the additional workshop/meetings
- Current Spring Tier 2 Assessments have been completed

## LISA Scheduling Software

- Proposal for new LISA specific Scheduling software presented
  - Software being developed by Steve Clout at Juan de Fuca
  - Purpose built for LISA which allows multi-level user access to upload game information
  - LISA looking to trail for Tier 2 season before moving ahead in September

# **BUDGET AND FINANCIALS (SB)**

• Executive Director Bancroft provided an overview of the Proposed Budget for 2024/2025 in the absence of Treasurer Wynn-Williams



- Three areas of note:
  - 1. Registration revenue higher than anticipated for the year
  - 2. Tier 2 costs also higher than anticipated for last season
  - 3. Tournament costs significantly up over previous years
- Board to review and approve at next board meeting with Treasurer Wynn-Williams present.

## **COMMITTEE UPDATES (SB)**

### **EDIA Committee**

- Committee met last week to discuss the results of the "Inclusion Survey"
  - Committee to draft an Executive Summary of the results to share with the LISA population

## **OTHER BUSINESS**

- LISA has received a formal complaint from Salt Spring United regarding the large number of teams to cancel away games at Salt Spring Island
  - Request LISA to address the situation and ensure teams make the trip to Salt Spring
  - LISA Board to review potential sanctions for failing to complete league obligations
