Office Report

- BC Soccer AGM and elections will occur before next the LISA board meeting.
- Reminder, VI Wave hosting BCSPL provincials June 23/24 on the Westshore
 - Will be attempting to book ferries for participants, it was noted participants should be able to walk on for free as it is a provincial championship
- Scholarship applications provided to the scholarship committee members, winners will be announced at the LISA AGM
- Employment contract reviewed and signed by LISA President
- Grandparent application presented with appropriate documentation

Technical Report

- Soccer 4 Life course has been set up for June 23/24th
 - Requires 12 more coaches to operate
- VIPL intake year players have been contacted and final assessments are being planned
 - Thanks to Joshua Hart for his assistance
 - Saanich has asked LISA to approve teams at Saanich but as that is not within LISA's right to approve. LISA has directed Saanich to direct their request to the presidents.
- Meeting with community partners on a regular basis regarding potential CSA changes to BCSPL programming

AGM Planning

- President Satterford will run the elections at the AGM
- Continue to look for potential board members
- Draft of the AGM booklet was distributed.
 - Final copy will be sent electronically to club presidents
- Executive Director to confirm Clubs have paid all invoices to ensure in good standing
- Award winners were reviewed and determined who will present each their award
- Reminder, no constitutional motions can be added to the meeting agenda as none have been provided under the necessary 45 days in advance of the meeting

Next season

- No Coastal B Cup Island Runner-Up made it to the finals
 - It was agreed one year is not a big enough sample size to do an evaluation at this stage
- U13 current message is no-cup play, meaning no Coastal Cup and no Provincials
 - Further discussion expected to determine if Island Invitational remains a one-off game or if a tournament format for an Island Championship/Island Invitational is a better format.
 - o Board Sub-committee formed to review calendar to see what is possible
- 2018/19 calendar reviewed

Website

- Analytics
 - o 26.000 new users
 - o 90,000 sessions
 - These numbers are sufficient for LISA to consider trying to monetize to the Victoria community
- Since it was new this year, will review website in the off-season

Other business

- BC Soccer updated their criminal record check policy to remove mybackcheck.com for approved agencies providing criminal record checks
- BC Soccer interested in reviewing the scope of LISA's Controls Review to determine
 if it might meet the BC Soccer requirements (currently only a minimum Notice to
 Reader meets the requirement)
- Board members want to know if BC Soccer has handled the discipline issue we forwarded to them
- Notice to Reader should be ready in time for the AGM
