#### **NEW BUSINESS**

#### **TECHNICAL REPORT**

- CSA youth license has asked for follow up information and it has been provided
  - Expect review will be in January



- VIPL
  - Have met with Karen Hood-Deshon and Derek Trimmer to discuss what Derek has learned from visiting the clubs regarding VIPL
    - Derek has met with 9 of the 10 clubs
    - Decision on whether VIPL will continue in the lower island will be made at the January President's meeting
  - LISA as a board should take a stance regarding how it feels about VIPL once the report has been reviewed
- Futsal jamboree will be held December 22<sup>nd</sup> at Pearkes Arena
- Coaching courses are ongoing
  - Head coaches who are required to have Soccer for Life to coach A and B
     Cup teams have been notified
  - o BC Technical Directors Diploma course will be held in February
    - LISA has offered Technical Directors \$300 to attend this course
  - C License participants were assessed in December

#### **OFFICE REPORT**

- Finances
  - The final recommendation of the Controls Review was completed, with the Board Terms and Reference document updated to reflect current practices for the role of treasurer
  - The draft 2019/2020 budget was presented and discussed
    - Two draft budgets are to be presented to the presidents at the President's meeting in January
      - At the request of the presidents, one draft will include revenue from transfers and releases, the other will be without revenue from transfers and releases
    - The clubs had previously been advised there would be an increase in fees for the 19/20 season since BC Soccer fees went up last year and LISA absorbed the cost - this is still true and clubs are aware the LISA fees are going up
- Random Roster Checks
  - One club has forwarded their random roster with two discrepancies
  - Two releases have been requested to make this team eligible

On a Motion duly made, Seconded and Carried it was resolved to approve these releases to make this team eligible – not unanimous

- Chapter 7 Registration Rules, Regulations and Policy
  - o Rule 705 3 A permits
    - At the LISA President's request, the maximum three intra-club permits per game was reviewed

  - There will be no changes to the Girls U14 Silver league as discussed during the November 2018 board meeting - it was reviewed with the club presidents at their November meeting
- Newsletter
  - The December newsletter will be going out early next week which will include all upcoming important dates and information
- Website and referee course
  - The website was recently updated to fix a few scheduling errors
  - One member has asked if there could be a full field referee course, John Kilbank looking into it
