• APPROVAL OF MINUTES:

• SPECTRUM TURF UPDATE (DB)

• Agreement in principle with the School District and the VISL as the main stakeholder



- LISA has been a part of the discussions
 - LISA provided letter of intent in 2018 for field space for the VI Wave
- STAR Project has applied for Infrastructure Grant
 - Other funding coming from VISL, Donations, and In-Kind Contracting
- STAR Project can update the grant application prior to December 31st, 2020
 - Asking LISA to make a "conditional donation" to strengthen grant application in return for field space
- LISA Board Discussed proposal at length
 - o Key Considerations:
 - Current financial situation due to COVID Pandemic not conducive to making a contribution at this time. Currently unclear what effect the COVID Pandemic will have on LISA financially
 - 2. STAR project may not serve all LISA members equally
 - **3.** LISA is aware of multiple Turf Field projects currently applying for Infrastructure Grants.

• LISA UPDATE (SB & AL):

- Updated Provincial Health Orders have moved all youth sport back to viaSport Phase #2 (BCSA Phase #1) and cancelled all adult team sport
 - Understanding that the majority of the LISA clubs have suspended programing early for the Winter Break
- Contingency plan to return to play in late January and adjust timeline as needed
- Stuart meeting with operator of Power Up Sports to begin training on new registration and scheduling system
- Andrew Latham spoke to the goals and objectives for re-imagining Tier
 2 Soccer in the Lower Island
