## **ROLL CALL & APPROVAL OF AGENDA:**

#### **APPROVAL OF MINUTES:**

## LISA UPDATE (SB):

- BCSA transfer deadline and LISA competitive roster freeze was January 15<sup>th</sup>
  Always a busy time of year in the office as teams prepare for Cup play
- "B" Cup playdowns began the January 18<sup>th</sup>/19<sup>th</sup> weekend
  - Island Finals to take place March 8<sup>th</sup>/9<sup>th</sup> with UISA hosting U14,U16, and U18 Finals, while LISA hosts U15 and U17
- Tim Satterford Cup Finals this weekend being hosted by JDF at Starlight and Goudy
- Tier 2 "Pre-season" to begin February 8<sup>th</sup>/9<sup>th</sup> before a break for Spring Break and competitive start of the West Coast League in April
  - Still unsure of UISA participation
  - Some LISA teams questioning cost/value of Tier 2 league
- LISA circulated the Boards letter, "Restoring a Culture of Respect and Unity", was picked up by CBC Radio
  - Stuart and Al both participated in separate radio interviews discussing the challenges of discipline and parent conduct in youth soccer

# **RDO UPDATE (AM)**

- Al Moir looking into "Friday Night Lights" games at Royal Athletic Park for next season
- LISA has enrolled over 200 new referees into the system, mainly small sided
  - Challenges at U17-18 Tier 3 and higher divisions finding qualified and capable referees
  - Early stages of approaching VISL and adult leagues to communicate and fill referee positions for more challenging LISA matches
- LISA exploring options for a "Referee Starter Kit" to provide the basic necessities at cost to new referees.
- Upcoming Tim Satterford Cup finals using a number of JDF referees and AR's

## **BUDGET AND FINANCIALS (AWW)**

- Treasurer Andrew Wynn-Williams provided a 3<sup>rd</sup> Quarter Budget Review
  - LISA is currently on budget and within a few percentage points of expenditures for expected year end



• A few discrepancies in budget items but expenditures on some items offset by savings in others

## **COMMITTEE UPDATES**

- Discipline Complaints and Appeals
  - A discipline complaints and appeals issue was discussed by the Board
  - President Synnuck had reached out to the parties and provided an update
  - The board discussed the need to review and update LISA's internal Discipline, Complaints, and Appeals policy to remove ambiguity and align with BCSA Discipline Rules and Regulations

## **OTHER BUSINESS**

- National Youth Club Licence
  - LISA has been in discussion with VI Wave and LISA member clubs with regards to National Youth Club requirements and District implications
  - LISA should seek direction and support from our member clubs regarding these issues and suggests setting up a meeting specific to these topics
- Club Insurance Update
  - President Synnuck discussed the current level of insurance coverage provided by BCSA
  - An independent review undertaken by Gorge board members suggests overall the BCSA coverage is good, but suggests individual clubs seek individual policy and liability insurance and liability coverage minimum of 5 million dollars per occurrence
    - There was no benefit in LISA clubs grouping insurance policies
  - President Synnuck to follow up and provide an overview for the Interlock Meeting
- Interlock Agenda
  - LISA Interlock scheduled for February 11<sup>th</sup>, at the Gorge Clubhouse
  - The board discussed and set the Interlock Agenda
